RULES & WAIVER OF LIABILITY

1. **ELIGIBILITY:** Contest is open to all residents 18 years or older. Employees of Holly Poultry Inc. are not eligible to enter. Void where prohibited.

2. **TO ENTER:** READ CAREFULLY THESE ARE THE OFFICIAL CONTEST RULES AND ENTRY FORM FOR THE HOLLY POULTRY WING WARS. INCLUDES RULES, ELIGIBILITY REQUIREMENTS AND WAIVER OF LIABILITY PROVISIONS. COMPLETE AND SIGN ALL FORMS BELOW.

3. **CONTEST RULES:** Contestant must be present at Hightopps Backstage Grill-Timonium, MD and registered at the registration table by 1:30 pm on Saturday, June 11, 2011 for check in and final instructions. Upon registering you will receive an official t-shirt and will be instructed to which qualifying round you participate in. A contestant will forfeit his/her place should he/she fail to register at the registration table by 1:30 pm on Saturday, June 11, 2011 and must be present by 7:15 pm at the registration table for the final round. Contestants will also forfeit his or her place if they leave the event after registration.

There will be 2-3 qualifying rounds starting at 2:00 pm with brief intervals between rounds. At 7:45 pm the top ten (10) contestants will compete in the final round for the Grand Prize. The object is to eat as many chicken wings (based on weight) as possible within the allotted time of 5 minutes for the qualifying round and 10 minutes for the final round.

Upon the completion of the round, judges will combine each competitors remaining food and accrued debris and weigh them on the official contest scale to determine the exact amount of weight eaten. Total weight of buffalo wings given to contestant MINUS total weight of remaining food and accrued debris EQUALS total wing meat eaten determines the winners. The formula for converting wing meat to wings for marketing and promotion purposes is: one half (½) ounce of wing meat eaten EQUALS one (1) buffalo wing.

Contestants may eat either sitting or standing in their designated area using hands only. Contestants will be allowed to drink only the water provided during the competition. Contestants must wait for the starting signal to begin eating and may not touch any wings prior to the starting signal. Contestants must stop eating and must promptly place their hands down at the ending signal. Contestants may not put additional chicken wings in their mouth after the ending signal, but will be allowed 15 seconds to swallow any chicken already in mouth. If a contestant throws up or regurgitates, he or she will automatically be disqualified. Contestants must have a neat clean appearance for the event. Casual clothing or active wear is appropriate.

Judges will be on hand to assure adherence to contest rules, weigh the amount of chicken wings eaten, monitor the "no throw up or regurgitating" rule, and to disqualify contestants who fail to adhere to the rules. The winner will be the contestant that consumes the most chicken wings in weight. In the event of a tie, after a brief interval, 1 minute and 30 second eat-off will take place until a winner is selected.

Grounds for disqualification include:

False or incomplete entry form or liability waiver

Any health risks that could jeopardize the contestant's health or wellbeing

Under the influence of any substance

Failure to register at the Information booth/registration table by 1:30 pm or failure to stay at the event after registration

Starting prior to the start signal

Continuing to eat after the ending signal

Throwing up or regurgitating.

Note: Holly Poultry Inc. judges reserves the right to disqualify any contestant for any reason without explanation In Holly Poultry Inc's sole and absolute discretion.

4. PRIZE AWARDS: Prizes will be awarded as follows:

• Contestant who eats the most chicken wings in weight during the final round in the allotted time of 10 minutes will receive the Grand Prize of \$1,500 prize money, 2nd place prize of \$800, 3rd place prize of \$450, and 4th place of \$250. Prizes will be awarded in the closing ceremony after 8 pm.

All qualified participating contestants will receive a HOLLY WING WARS T-Shirt.

All other prizes, if any, are to be announced.

No transfer or prize substitution by the contest winners is allowed. All federal, state and local taxes are the sole responsibility of the winner. It is the responsibility of the winners to comply with all instructions as to the pick-up, receipt, arrangements for or use of any prize won and failure to do so on a timely basis may affect the winner's right to claim or use the prize. All winners and participants agree to the use of their name, voice, likeness, for advertising or trade purposes and to cooperate reasonably in any effort to promote or publicize the Holly Poultry Inc.
